Cañón de Carnué Land Grant Hall Rental Fees Revised November 1, 2015

General provisions.

The hall will be cleaned prior to the event by the Cañón de Carnué Land Grant. Non heirs will be charged a \$150 cleaning fee in addition to hall rental, hosting fee, and other expenses. Heirs will be asked to make a \$150 cleaning deposit at the time the hall is reserved. Heirs will get their cleaning deposit returned in full if the cleaning passes inspection. Total net costs below for heirs assume the cleaning passes inspection. Confirmed heirs are charged a lower hall rental fee than non-heirs, but must be up-to-date in their dues for the previous five years to rent the ball at that lower rate. Confirmed heirs who are in arrears have the option of becoming current by paying \$75 (dues are currently at \$15/ year) and must attend two board meetings before they can reserve the hall. Confirmed heirs who are in good standing will have received a membership card indicating the date of their last dues payment. Rental of the hall requires that a member of the board unlock and lock the hall, and be present during the rental event. Should any issues arise during the event the renter must take direction from the board of trustees member present. That member will be paid a hosting fee of \$40 for the event (\$60 if the event extends beyond four hours). The hosting fee is waived for events associated with village celebrations (villages within the historic boundaries of the merced), and for funeral receptions made available for heirs. Note: the Cañón de Carnué Land Grant does not have a liquor license at present. The fee schedule below assumes no alcohol served, regardless of whether it is a day or evening event.

Evening events require a \$200 security fee for the hiring of security officers, whether or not alcohol is served. Evening events must conclude by 12 midnight, with one exception: any event honoring a minor, such as a high school graduation or sweet sixteen party must end by 11:00 pm.

- I. Daytime events (no security; no alcohol served; member of board of trustees must be available to cover the event and assume responsibility for the hall)
 - A. Village events associated of communities within the historic boundaries of the Merced (e.g., fiestas, posadas)
 - 1. No charge for use. However a \$150 cleaning deposit is required. (For conditions of return of deposit, see general provisions above.)
 - 1. Members in good standing: no charge for use, but a \$150 cleaning deposit is required.
 - Confirmed heirs not in good standing: no charge for use, but must pay \$75 (5 x \$15) and attend two board meetings to become a member in good standing. Also required: \$150 cleaning deposit.
 - C. Wedding or baby showers, baptisms, First Holy Communion, similar afternoon events without alcohol or security
 - 1. Members in good standing: \$190 (\$150 hall rental fee plus \$40 hosting fee). Also required: \$150 cleaning deposit.

- 2. Members not in good standing: \$265 (\$150 rental fee plus \$40 hosting fee) and \$75 and attend two board meetings to acquire status of member in good standing. Also required: \$150 cleaning deposit.
- II. Evening events (with security, but no alcohol served and no alcohol permitted on the premises; member of board of trustees must be available to cover the event and assume responsibility for the hall)
 - A. Benefit event to raise funds for medical expenses or funeral

1. Members in good standing: \$240 (no charge for hall rental, \$200 security fee, \$40 hosting fee) plus \$150 cleaning deposit.

- 2. Members not in good standing: \$315 (no charge for hall rental, \$200 security fee, \$40 hosting fee, \$75 and attend two board meetings before hall can be reserved) plus \$150 cleaning deposit.
- 3. Non heirs: \$650. Includes security and cleaning fee.
- B. Evening dance event (e.g., wedding reception or dance, anniversary, sweet sixteen, graduation party; see special hours restrictions for events honoring minors in general provisions, above)
 - 1. Members in good standing: \$460 (\$200 hall rental fee, plus \$200 security fee, plus \$60 hosting fee) plus \$150 cleaning deposit.
 - Members not in good standing: \$535 (\$200 hall rental fee, plus \$200 security fee, plus \$60 hosting fee, plus \$75 and attend two board meetings before hall can be reserved).
